2024 MUDDERS – ENTRY FORM

- All Play will be from the White Tee Markers (Men); Red Tee Markers (Women)
- Valid USGA Handicap Required (*Non-Handicapped Players may play to a 0 Handicap*)
- Maximum Course Handicap Allowed is 20. Any player may “play down” to a 20.
- A Schedule of Matches will be available NO LATER than Oct. 29th
- All Matches will have a window of time for completion (*Based on total entries*)
- A Consolation Bracket will consist of Teams who lose in the 1st Round ONLY—Any 1st Round BYE Matches would be considered a WIN.
- Teams will be expected to schedule their matches in a **TIMELY MANNER**
- Any Match Result that is Not Turned into the Pro Shop by the deadline will result in a Coin Flip to decide the Winner.
- If a team is continually un-available or un-reachable to play or schedule a match; The Tournament Committee may deem they have forfeited any un-played matches.
- The Low Handicap Index between 8/15–10/15 will be used throughout the event; However, The Tournament & Handicap Committee may adjust a players Tournament handicap DOWN, based on extraordinary play over the Winter Months.
- Winning Teams MUST turn in Mudders Match Scorecards to the Golf Shop; Failure to return cards may result in Team Disqualification (Handicapping Purposes).
